SUBJECT: 2019 IBEW/NECA Employee Benefits Conference Registration

Registration to attend the 2019 IBEW/NECA Employee Benefits Conference is now open. This year, the conference will be held at the TradeWinds Island Grand Resort in St. Pete Beach, Florida from January 29-30, 2019. Pre-conference activities will begin with a workshop late in the afternoon of Sunday, January 27, 2019, followed by a reception that evening. There will be additional workshops in the morning of Monday, January 28, 2019, addressing fiduciary responsibility, the Pension Benefit Fund, the Employee Retirement Income Security Act (ERISA) of 1974, and the proper construction of a fund portfolio. Similar to past conferences, the ERTS update and fund administrators meeting will be held on Monday, January 28, 2019, beginning at 1:30 pm. The theme of the conference is Fiduciary Responsibility: I Am My Brothers and Sisters Keeper, and its purpose is to provide information and updates for business managers, chapter managers, plan administrators, and fund trustees involved in today's Taft Hartley world of multi-employer fringe benefits. In addition to education provided in the workshops, attendees to the conference will hear from speakers involved in prescription drug coverage, pension issues, health insurance, investment trends, and legal issues.
